Re: Notification of Claimed Copyright Infringement Pursuant to 17 U.S.C. § 512

Dear Tucows,

My firm represents The Football Association Premier League Limited (“Premier League”), which owns copyrights in broadcasted Premier League football (soccer) matches, including the right to publicly perform those copyrighted works. Premier League has determined that users of your services are infringing Premier League’s copyrighted works through the following websites and domain names:

Tucows is asked to remove or disable access to Premier League's copyrighted works, which, based on the infringement that has occurred to date through the websites and domain names identified above, will continue to be infringed in this same manner throughout the Premier League season and into future seasons. In addition, enclosed is a subpoena pursuant to 17 U.S.C. § 512(h) that instructs Tucows to provide Premier League with information sufficient to identify the alleged infringers that are associated with these websites and domain names, including those contained in the backend links.

We are providing this notice based on our good faith belief that the use of Premier League's matches in the manner occurring through the websites and domain names identified above is not authorized by Premier League, its agents, or the law. The information in this notification is accurate and, under penalty of perjury, we are authorized to act on behalf of Premier League, which owns exclusive rights under copyright that are being infringed in the manner described herein. This letter is without prejudice to the rights and remedies of Premier League, including to recover damages and any other claims for relief, all of which are expressly reserved.
